Each student will receive a minimum of 24 hours of classroom instruction and a minimum of 6 hours of behind the wheel driving instruction. Segment I instruction program is authorized by the "Driver Programs Division" to allow Rod's Driving School Inc. to test student achievement after the 24 hour of classroom instruction and after the 6 hours of the behind-the - wheel driving instruction. Issuance of a Driving Education Certification Segment I is permitted after compilation of 24 and 6 only if the student has passed the classroom phase with an 80% or greater achievement, and has demonstrated achievement of the driving objectives in the behind-the -wheel phase. Additional instruction may be given to those students who are unable to demonstrate the 7 basic driving skills. **\*Notice Statement: "This school is required to be licensed by the Michigan Department of State, "Driver Programs Division". If you have a complaint which you cannot settle with this school, write: Michigan Department of the State, Driver Programs Division, Lansing Michigan 48918. Completion of driver training instruction does not guarantee qualification for a driver license. Rod's Driving School Inc. will conduct the behind the wheel instruction in a dual controlled automobile, fully insured, covering each student enrolled in the program."** **"THE DRIVING RECORD OF EACH INDIVIDUAL INSTRUCTOR IS AVAILABLE FOR REVIEW UPON REQUEST". Characteristics which must be included:**

1. 30 and 6 is the BASIC STANDARD
2. Driver Programs Division approval to test after 24 and 6
3. Approval achievement requirements, in Segment #1
4. Additional instruction provided, when required, at no additional cost
5. Students will receive 4 or more hours of behind -the-wheel observation time as a passenger in Seg. I

**AGREEMENT**

This agreement, made between Rod's Driving School Inc. and Parent of Student \_\_\_\_\_

- 1) Student, Parent or Guardian of student **agrees to pay** \$400 at time of registration.

- 2) **"The student must be at least 14 years /8 months of age by the beginning of class (verification by birth certificate required)."**

3) Rod's Driving School Inc. reserve the right to cancel or terminate the course of instruction, because of conduct or acts that its agent feels endangers safety or compromises that position of Rod's Driving School Inc., its agent or students enrolled in the course.

4) **If the above circumstances arise, or due to any reason the student does not or cannot continue the course, he/she will be refunded the full price minus \$100 registration fee. However, once he begins the driving portion an additional charge of \$75 per lesson will be deducted. If a student misses any assigned drive time, a \$75.00 fee will be charged per missed session.**

5) Upon the successful completion of the course, said student will receive a Driver Education Segment 1 Certificate, certifying the state requirements for under 18 safety education courses. **A \$25.00 fee will be charged for replacement of Segment I certificate.**
